Important! Recommendations on submission of correct details for SWIFT transfers. For prompt receipt of SWIFT transfers in foreign currency, please note the following requirements:

1. The transfer may be a part of non-commercial transactions and not apply to investment or business activities. Therefore, for your convenience, please don't indicate references to invoices/contracts as a payment purpose.
2. To ensure prompt transfer receipt, we strongly recommend that you coordinate the transfer currency with the sender - it must be the same as your card currency. If you don't have a card in the desired transfer currency, it is preferable that the transfer is made in US dollars (USD) or euros (EUR).

Attention! Completion of transaction for which incorrect details were submitted may require inter-bank communication, and a corresponding fee will be subtracted from the transfer amount. Therefore, you should pay close attention to submission of correct details for SWIFT payments receipt. Make sure that you provided the Beneficiary with correct personal information.
